Initial deposit is non-refundable after 10 days. Final payment of any outstanding balance is due 20 days prior to your event if paying by personal check. If arrangements are made to pay the remaining balance on the day of your event payment must be in the form of cash. Our company shall not be held liable for any equipment damage or personal injuries, which may occur during your event; or to unforeseen equipment or hardware failure due to acts of nature or problems cause by nature; or attributed to the facilities or at which the event is held. Upon the Dj request the client shall remove any person who in the opinion of the Dj poses a threat to Dj personnel or equipment. If the removal is not handled and the threat continues, disc jockey services may be terminated without loss of compensation. The client will assume full responsibility for repairs or replacement of damage equipment due to the negligent acts of the clients, the clients' family, relatives, friends, guest and members or associates of their organization. I hereby release JustMyDj.com, its officers, members, employees, agents and volunteers from any and all liabilities or claims of every kind, nature or character arising out of or in any way connected with this event.

Payment Schedule:

Make check payable to: JustMyDj.Com. Events schedule beyond two month from the contract date require 50% of the remaining balance paid within 60 days of the contract date. All cancellation notice must be received in writing by certify mail within 10 days to have your deposit refunded. If contract is cancel by client prior to event date all mileage charges and other expense incur associated with client will be deducted from deposit and an additional 50%. The remaining balance of their payment/s will be refunded within 90 days. **Overtime Disc Jockey Service is subject to availability at a rate of \$100.00 per hour payable by cash at time of request.**

The Event Formalities:

Client must submit accurate information regarding bridal party, song list and program activities 4 weeks prior to your event date. This allows JustMyDj.Com time to prepare your music program for your formalities and introductions.
